

## [RO] Modification of the Public Audiovisual Services Law

On 5 June 2015, the Romanian President promulgated the draft Law with regard to the approval of the Government Emergency Decree no. 110/2013 for the completion of Act no. 41/1994 on the organization and operation of the Romanian Radio Broadcasting Corporation and of the Romanian Television Corporation (Proiect de Lege privind aprobarea Ordonanței de urgență a Guvernului nr. 110/2013 pentru completarea Legii nr. 41/1994 privind organizarea și funcționarea Societății Române de Radiodifuziune și Societății Române de Televiziune). The new law no. 134/2015 was published in the Official Journal of Romania no. 403 of 9 June 2015 (see IRIS 2003-4/24, IRIS 2003-8/25, IRIS 2013-5/37, IRIS 2014-1/38, and 2014-6/30).

Through the modification of Article 46 of the Law no. 41/1994 the Government Emergency Decree was meant to allow the Standing Bureaus of Romania's Parliament chambers (Chamber of Deputies and Senate) to appoint for 60 days an interim Director General of the public broadcasters with limited powers in case the plenum of the Parliament is not reached.

In May 2014, the Law had been sent back to the Parliament by the former President with a request to be reviewed because, in his opinion, the Government Emergency Decree no. 110/2013 did not stipulate how many interim mandates could be decided by the Parliament, and the lack of clear provisions could have affected the independence of the public broadcasters. It should be noted that the Chamber of Deputies (lower chamber) had rejected the draft law sent back by the former President on 11 February 2015, while the Senate had adopted the document on 18 May 2015. The decision of the Senate (upper chamber) was final.
